

Attic Self Storage Strike-ing Kits Facebook Competition Terms & Conditions May 2023

The promoter is Loft Management Services (company no. 11921179) operating as Attic Self Storage Limited (company no. 5999141) whose registered offices are at 3rd Floor, 72 Borough High Street, London, SE1 1XF.

The competition gives one entrant the chance to win a single printed kit for themselves by sharing their design on Facebook or Instagram

To take part, children must create and submit a kit design using the template found via the link. The kit will consist of a pair of shorts and a T-shirt. Designs must be submitted using this template, with the Attic logo visible on the kit. Entries will be judged on factors including creativity, uniqueness, and ingenuity.

Entries need to be uploaded in the comments section in the form of a jpeg.

Only one submission can be accepted per child.

There is no entry fee.

Submissions involving indecent or discriminatory language will be excluded.

The closing date for submissions will be 23:59 on Friday the 19th of June 2023. After this date, entries will no longer be able to be included in the competition.

No responsibility can be accepted for submissions not received for whatever reason.

One winner will be selected by a panel of independent judges.

The winning design will need to be recreated digitally to allow for production which may result in minor changes to the original submissions.

By entering this competition, entrants agree to have their design, squad name, and location shared with the media. The winner must also be willing to share an image of the printed design.

The rules of the competition and how to enter are as follows:

1. The competition will be open from 26/05/23 and close at 23:59 on 19/06/23. All entries must have been received by the closing date and time.
2. Entrants must create an A4 design of a football kit using the Attic template or a free-hand design including the logo, as a base. Entries must be uploaded in the comments section of the post in the form of jpeg.

3. By entering this competition, the entrant agrees to have their design shared with national and regional media and agrees to be contacted for PR purposes and agrees to take part in a photocall of their designed kit, between 03/07/23 and 17/07/23.
4. The promoter reserves the right to cancel or amend the competition and these terms and conditions without notice in the event of a catastrophe, war, civil or military disturbance, act of God, or any actual or anticipated breach of any applicable law or regulation or any other event outside of the promoter's control.
5. Any changes to the competition will be notified to entrants as soon as possible by the promoter.

7. The competition is open to children between the ages of 6 and 15 living in a London Borough.
